





## **Contents: Phase 2 – Option Selection**

• Article 5(1)(d) of the amended EIA Directive:

"[The information to be provided by the developer shall include at least:] a description of the reasonable alternatives studied by the developer, which are relevant to the project and its specific characteristics, and an indication of the main reasons for the option chosen, taking into account the effects of the project on the environment [...]."

- Article 6(4) of the Habitats Directive.
- Other potentially relevant environmental law.

## **Contents: Phase 3 – Design & Environmental Evaluation**

#### **Screening decisions – General Principles**


Screening decisions must be:

- Made in writing;
- Reasoned, e.g.:
  - *'include the main reasons and considerations on which the decision is based';* and,
  - 'contain or be accompanied by all the information that makes it possible to check that is based on adequate screening'.
- Made available to the public, e.g.:
  - May be inspected; and,
  - Placed on the authority's website.
- Made formally via properly delegated authority or Chief Executive's Order.

Screening decisions are <u>not</u>: made by an ecological consultant; or, an ecology report.

- Screening for Environmental Impact Assessment.
- Screening for Appropriate Assessment.
- Is the development 'Part 8' development?
- Is the development subject to Section 38 of the Roads Traffic Act 1994? ('Traffic calming measures')
- Is the development subject to Section 95 of the Roads Traffic Act 1961? ('Traffic signs')
- Is the development subject to Section 138 of the Local Government Act 2001? ('Prior information to elected council').

### **Preparation of statutory documentation:**

- Preparation of Environmental Impact Assessment Report.
- Preparation of Natura Impact Statement.
- Preparation of documents associated with a Section 177AE application.
- Preparation of the 'Part 8' documents.

#### **Statutory processes:**

- Application under Section 51(2) of the Roads Act, 1993 ('proposed road development which is subject to an environmental impact assessment').
- Application under Section 177AE of the Planning and Development Act, 2000 ('Appropriate Assessment of certain developments carried out by [...] local authorities').
- Project subject to Section 179 of the Planning and Development Act, 2000/Part 8 of the Planning and Development Regulations, 2001 ('Local authority own development').
- Other relevant statutory processes:
  - Section 38 of the Road Traffic Act, 1994 ('*Traffic calming measures*').
  - Section 95 of the Road Traffic Act, 1961 ('*Traffic signs*').
  - Section 138 of the Local Government Act, 2001 ('*Prior information to elected council*').




## **Contents: Phase 5 – Enabling and Procurement**

- 'Lifespan' of consents
  - Legacy 'Part 8' projects
  - Screening for EIA decisions
  - Article 6(2) of the Habitats Directive/Article 27 of the Habitats Regulations 2011 – Ballyboden Tidy Towns Group v. An Bord Pleanála – taking appropriate steps to avoid deterioration/significant disturbance in European sites.

## **Contents: Phase 5 – Enabling and Procurement**

 Environmental condition enforcement



- not exceeding 6 months or both, or
- on conviction on indictment, to a fine not exceeding €500,000 or to imprisonment for a term not exceeding 3 years, or both. (See s.51C(4), s.51E(3), s.51F(3) and 51G(4) of the Roads Act, 1993).

# Implications

## Implications

- [RE] [ENV] Technical Document.
- Publication of the document should:
  - Help increase the legal robustness of applications and screening decisions.
  - Potentially lower risk of:
    - Permissions being refused;
    - Applications for judicial review; and,
    - Successful judicial reviews.
  - Improve the quality of projects.
- Will need regular update (e.g., Planning and Development Bill 2022).
- Should be expanded to include other areas of law (e.g., Water Framework Directive, CPO, foreshore development).
