
#### Outline of TII Publications

- Bituminous Materials Product Category Rules Standard
  - The proposed standard is a new standard based on and complementing EN 15804, ISO 14025 and IGBC document "Product Category Rules: Part A".
  - This document provides additional rules for Life Cycle Assessments (LCA) and Environmental Product Declarations (EPDs), specifically for bituminous mixtures. It complements the core product category rules for all construction products and services as established in EN 15804 as well as the additional rules set in the IGBC document "Product Category Rules: Part A".
  - An EPD communicates verifiable, accurate, nonmisleading environmental information for products and their applications, thereby supporting scientifically based, fair choices and stimulating the potential for marketdriven continuous environmental improvement.

- Drainage Series 500 Updates
  - Technical review of DN-DNG-03022 with regards to catch pit depths and pipe sizes and new SCDs.
  - A full review of the SCDs last published in 2015.
- Landscaping Specification
  - There is currently no Standard or Guidance note available relating to the design and detailing of soft landscape treatments and planting associated with National Road Schemes in and around settlements. A new Standard will be published along with an Overarching Technical Document.
- Population and Human Health Assessment Standards
  - There are inconsistencies in reporting and assessment of Population and Human Health
    Assessments in Environmental Impact Assessment Reporting for road, greenway, and active travel
    schemes. A new Standard is being developed to address this.

- Circular Economy Workbooks
  - A series of Circular Lifecycle Guides for Project and Programme Managers will be developed for different assets Each Circular Lifecycle Guide will include circular economy principles, objectives, actions and worked examples of how the principles will be applied to projects.
- Variable Message Signs Standard
  - The current TII VMS standard, DN-ITS-03037, is now some 20 years old, the standard quotes TD 33/90 which is 30 years old. Technology around, and the implementation of, VMS has changed substantially in the 30 years since TD 33/90 was written.
- Aesthetics of Road Structures
  - Currently the requirements for bridge aesthetics and typical/standard details are defined by the Employer in the contract documents. The objective of this new standard is to provide an overarching document on the aesthetics of road structures – it will cover aspects related to processes and procedures, as well as requirements related to structural form and detailing principles.

- Updates to Series 600
  - CC-SPW-00600 sets out minimum requirements for Earthworks. The current version of Series 600
    was published in 2013. It is proposed to update this specification to reflect advancement in industry
    standards and best practise over the intervening period and, also to align the specification with the
    sustainability and circular economy principles in terms of the approach to materials management,
    optimal reuse of materials and minimisation of waste.
- Ground Investigation Guidance
  - Ground investigation data plays a crucial role in earthworks design. This guidance document intends to assist Employers and Consultants in the planning, design, procurement, supervision, and management of ground investigations.
- Falling Weight Deflectometer Guidance
  - To facilitate the implementation of the new IAPDM performance-based approach to pavement design for new and existing pavements, TII require the development of a methodology for the works performance testing for UGM and bound pavement layers using FWD, and to bring together the pavement assessment methodologies for existing pavements including FWD, GPR, DCP etc. under a single document.

- Vehicle Restraint Systems Ramped Terminals
  - Standard Construction Details will be published presenting suitable anchorage options for use with ramped down terminals in addition to any updates required to Standard.
- Passive Safety of Road Equipment
  - Develop a national Standard relating to the use of passively safe products on the national road network and address any inconsistencies that may currently exist in the Specification for Works (SPW), associated guidance (GSW) and Requirements for Measuring and Pricing (RMP) documents under the Construction and Commissioning (CC) activity of TII Publications.
